## Greetings!!

The Employees' State Insurance Corporation, (ESIC) had rolled out an ambitious project "Panchdeep 1.0" in 2011 through a national digital network in all the 2300+ locations with a view to provide hassle-free health and social security services to the stakeholders as well as for transforming its business into total e-governance.

- 2. Project Panchdeep 1.0 is one of the largest e- governance programmes of the country to provide online facilities to the employers, insured persons, ESI staff, third parties, government agencies, suppliers, and other stakeholders. It provides key functionalities such as registration of employers and beneficiaries, deposition of contribution, disbursement of cash benefits and documentation of medical services for all insured people.
- 3. Further, over recent years, the complexity of tasks undertaken by ESIC has notably intensified. Furthermore, in the coming years, the functions that will be performed by the ESI Corporation would become more and more diverse, and therefore, expectations of our IPs/ beneficiaries are bound to increase. In these circumstances, we have to leverage information technology to ensure that delivery standards are continuously upgraded and complexities of managing a large and diverse organization like ESIC and its related offices under the State Governments, are properly addressed. However, the existing e-governance platform of ESIC, Panchdeep 1.0, is becoming technologically outdated and is less scalable. It has started showing strains in terms of its adaptability, user friendliness and infrastructural / connectivity facilities.
- 4. A new platform shall be needed which shall be future-ready without showing strains in any aspect, whether connectivity or adaptability or ease of operation or Security. ESIC aims to build a new-age e-governance project (Panchdeep 2.0)
- 5. In this context, ESIC has engaged M/s Deloitte as Consulting Entity for Project Management (CEPM) agency. This consulting entity is assisting ESIC, in designing roadmap for Panchdeep 2.0 and getting it implemented through technological improvisations in terms of hardware, software, connectivity and business reengineering to make it more flexible, adaptable and user friendly.
- 6. To implement the best available solutions and leverage emerging technologies for building Panchdeep 2.0 that deliver a seamless experience to its stakeholders, ESIC has been following a consultative approach to engage with the industry participants for their viewpoints, suggestions, and concerns on Panchdeep 2.0. These inputs will help in drafting an informed Scope of work for proposed Request for Proposal (RFP) for Panchdeep 2.0.
